*WHEREAS, schools can play a crucial role in facing the increasing challenge of finding common ground among those of differing cultures and attitudes;*

*WHEREAS, a quality civic education should help young people acquire and learn to use the skills, knowledge, and attitudes that will prepare them to be competent and responsible citizens throughout their life;*

*WHEREAS, the importance of a student’s grasp of the concepts of civic responsibility and respect for others cannot be underestimated;*

*WHEREAS, the First Amendment enables Americans to find common ground for living respectfully and civilly with one another in the midst of diverse opinions;*

*WHEREAS, character and citizenship education should emphasize that each individual is responsible to respect others and their freedom of conscience;*

*WHEREAS, students should understand that respecting others is crucial, that debate and disagreement are vital in a democracy, and that individuals and groups must resolve their differences and learn to live in collaboration with those who do not agree;*

*WHEREAS, respect demands that the manner in which issues are debated is just as important as the topic, and that the heart of good citizenship is a strong commitment to the civic values that enable people to find common ground and treat one another with civility and respect in spite of differences;*


*WHEREAS, promoting civic responsibility and respect for others can help prepare today's students to make a profound impact for the common good and the future of their communities, state, nation, and the world;*
